Hello again, I am filling in for our President Jack Kempter, who continues to take his chemo treatments weekly and is making progress on the treatment. Jack wants everyone to know that he thanks them for their thoughts and prayers for him and he hopes to be back to see everyone soon.

Here is a few things to think about during this unusual times in our lives.

I have been thinking about this Corona Virus and I find that their is a comparison between a combat situation in the military and this virus and it kind of goes like this!

In combat we carried a weapon to protect us. Now we use and wear a face mask to defend ourselves.

In combat we wore Body Armor (if we had it) to deflect projectiles, now we use hand washing with sanitizer to deflect the virus,

We used to "Dig in" to protect ourselves from attack. Now we stay at home to avoid contacting the virus.

We used to avoid contact with anyone we were not sure of in case they were the enemy. Now we avoid contact with people because they may be infected!

We didn't travel if possible as it might not be safe for your safety and long life, now we practice the same.

In combat we depended on our Friends in the Artillery or Armor or Air Cavalry or Air Force, or Navy to bail our Ass out of trouble. Now we depend on our Doctors and nurses and medical knowledge on what it takes to survive and all the things incumbent in surviving. We must have Faith in God, our Faith in our Country, our Faith in our fellow Americans do what it is right for the times and that is.

Stay home, use the proper precautions, wear your personal Flak Jacket, dig a proper foxhole and stay down and safe until the orders to move out comes down! Oh Yes and keep on the good side of God.

in Vietnam or into the island waterway/rivers (brown waters) of Vietnam. These sailors, known as Blue Water sailors have been denied VA benefits due to Agent Orange exposure for many years by the Department of Veterans Affairs, but now the law has recognized that anyone who served within 12 nautical miles in the territorial sea of the Republic of Vietnam was likely exposed to Agent Orange and is, the, entitled to service connection for those diseases known to be caused by that exposure. This change in the law by Congress will lead to grants of service connection for many veterans, but it's important to know how to get those disability benefits.

When we are in high school we bond friends with other kids we grow up with and we never know just where life will take us



Randy Holiday and Denis Zimprich were two that started in Hazel High School Denis graduated in 1967 and Randy in 1968. We had the same priest, he went to Grover and Randy to Henry.

Randy got to Vietnam Jan 22nd 1970 and was assigned to HQ Company as Battalion Armor. I stood outside the Armor room

and there was Denis coming down the street towards me. I couldn't believe we had been sent to the same battalion. He was wounded in action and on crutches. When he recouped from being hit by the punji-sticks he went back to the fields for his next mission.

A couple days later I was in the first sergeant office and the phone ran, he told me to answer it. The said line Number 1440 in A Company was killed in action last night. I have been to visit him every year for 50 years at the Grover Catholic Cemeterv.




# Nomination Committee looking for Officers and Board Members
